The Light of Hope Breakfast both celebrates and expands the service of CASA volunteers working to give hope to abused and neglected children. This free, one-hour breakfast is an opportunity to learn more about CASA services for our most needy and vulnerable children, and to make a pledge, with no minimum or maximum, to support these critical services. This year, we anticipate nearly 500 attendees and all proceeds from the fundraiser will go directly to Child Advocates-Denver CASA to help support the mission to recruit, train and manage additional volunteers to advocate for abused and neglected children in our community.

### Who will be speaking?



Chadwick Sapenter, 32, entered foster care at the age of 15 along with his two younger brothers and aged out at 18. He went to college initially on a football scholarship and graduated from Texas State University. Sapenter is the CEO and founder of Little Book of Words Publishing, LLC, based in Austin. He also authored the company's first book, *The Little Book of Words Every Foster Kid Should Know*. One of his greatest joys is speaking to people involved in the child welfare system at all levels to provide hope, insight and inspiration. We are excited to have Chadwick share his story about how CASA helped him thrive in the system.
